Amending the Officers Scheme of Delegation following the re-structuring of the Democratic and Legal Services

Penderfyniad/Decision :

Addasu Cynllun Dirprwyo Swyddogion – Rhan 13 o'r Cyfansoddiad yn unol ag Atodiad 1.

To amend the Scheme of Delegation to Officers – Part 13 of the Constitution in accordance with Annex 1.

Cyflwyniad/Introduction

O ganlyniad i ail strwythuro Adran Gwasanaethau Democratiaeth a Chyfreithiol ac yn benodol dileu swydd Pennaeth Democratiaeth a Chyfreithiol mae angen dirprwyo dyletswyddau'r swydd i ymateb i'r strwythur newydd. Nid yw hyn yn golygu newid y cyfrifoldebau penodol.

Mae'r cyfansoddiad yn caniatáu i Arweinydd y Cyngor addasu y Cynllun Dirprwyo sydd ynglŷn â phwerau gweithredol (Adran 5 para 5.8.3). Mae gofyn ei fod yn ymgynghori â'r Pennaeth Gwasanaethau Democratiaidd ynglŷn â'r bwriad ac yn adrodd ar y newidiadau i'r cyfarfod nesaf o'r Cyngor wedi'r penderfyniad.

As a result of the re-structuring of the Democratic and Legal Services Department and specifically deletion of the post of Head of Democratic and Legal Services it is necessary to delegate the duties of the post in response to the new structure. This does not involve changing the specific duties.

The Constitution permits the Council Leader to amend the Scheme of Delegation in relation to executive functions (Section 5 para 5.8.3) . In order to do so he is required to consult with the Head of Democratic

Services on his intentions and report to the next meeting of the Council following the decision.

For the avoidance of doubt this authority includes the authority to take all procedural measures including the serving of statutory or non-statutory notices or counter notices and eviction notices.
