PENDERFYNIAD/DECISION

I gymeradwyo dynodi holl ardal weinyddol Cyngor Gwynedd yn unol ag Adran 56 i 60 o Deddf Tai 2004 yn Ardal Trwyddedu Ychwanegol ar gyfer Tai-mewn Aml-Ddeiliadaeth (TAD) am gyfnod pellach o 5 mlynedd o'r 1af o Ebrill 2016.

I fabwysiadu ffi trwydded ar sail £140 y llofft mewn llety gaiff ei rannu, neu fesul fflat hunangynhaliol mewn adeiladau sydd wedi eu troi yn fflatiau a bod hyn yn parhau am gyfnod o 5 mlynedd.

*To confirm the designation of the whole of the administrative area of Gwynedd Council as an Additionnal Licencing Area for Houses in Multiple Occupancy (HMO) in accordance with Section 56 to Section 60 of the Housing Act 2004, for a further period of 5 years from the 1st of April 2016.*

*To adopt a licence fee on the basis of £140 per room within properties which are shared, or per self contained flat in buildings which have been converted to flats, and that this remains for a period of 5 years.*

**RHESYMAU DROS Y PENDERFYNIAD/REASONS FOR THE DECISION**

Cynhaliwyd ymgynghoriad o'r bwriad ac adroddir ar ganlyniadau'r drefn o fewn yr Atodiad ynghyd a'r ymateb. Mae'r rhesymau manwl dros y penderfyniad sy'n dwyn canlyniadau'r ymgynghoriad i ystyriaeth wedi hamlinellu yn yr atodiad.

Pum mlynedd yw'r cyfnod hiraf y gall dynodiad TAD "HMO designation" fod mewn grym yn unol ac adran 60 (2) Deddf Tai 2004. Bwriad yr argymhelliad o fewn y daflen yma yw dynodi am gyfnod pellach o 5 mlynedd.

Cyflwynwyd y cynllun ar gyfer cofrestru eiddo TAD sy'n syrthio y tu allan i ofynion y Cynllun Trwyddedu Gorfodol. Mae'n gosod ffioedd i drwyddedu'r TAD hynny gan ystyried costau gweinyddu'r cynllun am gyfnod y drwydded, sef y pum mlynedd nesaf. Mae'r cynllun yn gosod safonau penodol yn eu lle sydd wedi eu hymgorffori fel amodau'r drwydded a fyddai yn berthnasol i holl anheddau trwyddedig.

Credir fod y drefn yn holl bwysig o ran gwarchod a chynnal safon eiddo a diogelu landlordiaid a thenantiaid.

*A consultation was held regarding the proposal and the results of that process*

*together with the responses are reported on in the attached Appendix. The detailed reasons for taking the decision, which takes into account the results of the consultation, are set out in the Appendix.*

*Under section 60(2) of the Housing Act 2004 the maximum period of HMO designation is 5 years. The intention of this proposal is to designate for a further period of 5 years.*

*The scheme was introduced to allow the registration of HMO's which fell outside the compulsory Registration Scheme. It confirms the registration fees which will apply for HMOs with regard to the cost of administering the scheme which will apply for the next five years. The scheme confirms set standards which will be incorporated within the licence conditions and which will apply to all licenced residencies*

*This arrangement is essential in order to safeguard and maintain the quality of properties and to protect landlords and tenants.*
