### **FUNDING: Welsh Food and Drink Industry – The Decarbonisation and Covid Challenge Fund**

### **REGULATION: Changes in allergen labelling requirements**

## **COVID-19: Deadline for Covid-19 sick pay**

The UK Government has updated its guidance for claims made under the Coronavirus Statutory Sick Pay Rebate Scheme. Employers can only claim back statutory sick pay paid to employees due to Covid-19 who were off work on or before 30 September 2021. Claims must be submitted or amended on or before 31 December 2021.
