## **EMPLOYMENT: Preventing sexual harassment at work – Hospitality**

A majority of bar and waiting staff say that they have either experienced or witnessed inappropriate sexual behaviour. All employers have a duty of care to protect their workers, and not taking reasonable steps to prevent sexual harassment means a business can be held legally responsible should an instance occur.
