COVID-19: Economic Resilience Fund (ERF): July/August support open for businesses with a turnover of £85k+

Businesses with a pre-COVID turnover of £85,000+, directly impacted by the restrictions in place during July and August 2021, can apply to the Economic Resilience Fund for financial assistance to help meet their operating costs (excluding staff wages). The fund will open today, 13 July 2021 until 12:00pm 27 July 2021. You can check your eligibility by going to:

Applications for businesses with a pre-Covid turnover less than £85k will open on 26 July 2021 (more details to follow)

COVID-19: Self-Employment Income Support Scheme SEISS – fifth grant

You can claim the fifth grant available under the Self-employment Income Support Scheme (SEISS) if you think that your business profit will be impacted by coronavirus (COVID-19) between 1 May 2021 and 30 September 2021. If you're eligible based on your tax returns, HMRC will contact you from mid-July to give you a date that the claims service will be available to you from. It will be

given to you either by email, letter or within the online service. The online service to claim the fifth grant will be available from late July 2021. For more information, go to:
