- CE Marketing Extension:

The UK government has announced plans to introduce legislation which will enable CE marked goods to continue being placed on the British market until 1 January 2023. All product sectors now have until 1 January 2023 to get ready to use the UKCA marking, with the exception of medical devices, for details go to:

The Port of Holyhead will process Office of Transit and CITES checks, so you'll need to go to Holyhead Interim Inland Border Facility Service when moving goods with an ATA Carnet, Office of Departure or Office of Destination. For more information, go to:
