Alert level four restrictions across Wales from 6:00pm on 25 December 2020

Wales will move to alert level four – the highest level – at 6:00pm on Christmas Day.

- All hospitality, non-essential retail, close contact services and all leisure and fitness centres must close.
- Tighter restrictions on travel, household mixing, requirements to stay-at-home and holiday accommodation will apply from 28 December 2020, after the five-day Christmas period.

Brexit: The End of the EU Transition Period

The UK left the EU on 31 January and has been in a transition period which will end on 31 December 2020. During the transition period, the majority of the current EU rules and trading arrangements have remained in place with no significant changes in most areas. However, the end of the transition period is fast approaching and this will mean changes to the current rules on trading, as will the right to travel without visas to other EU countries. Here is information from the UK Government that could be of help to you::
