## **COVID-19: Vaccination clinic – Caernarfon**

Vaccination clinics will be held at the Tennis Centre, Caernarfon, LL55 1DU, for both 18-39 year olds and age 40+ to get their first vaccination, or second dose with a 6 week interval between both doses. These will be held from 8:00am – 4:00pm on the following dates:

- 25 July 2021 – Astra Zeneca vaccine for age 40+
- 28 July 2021 – Astra Zeneca vaccine for age 40+
- 29 – 30 July 2021 – Pfizer vaccine for ages 18-39
