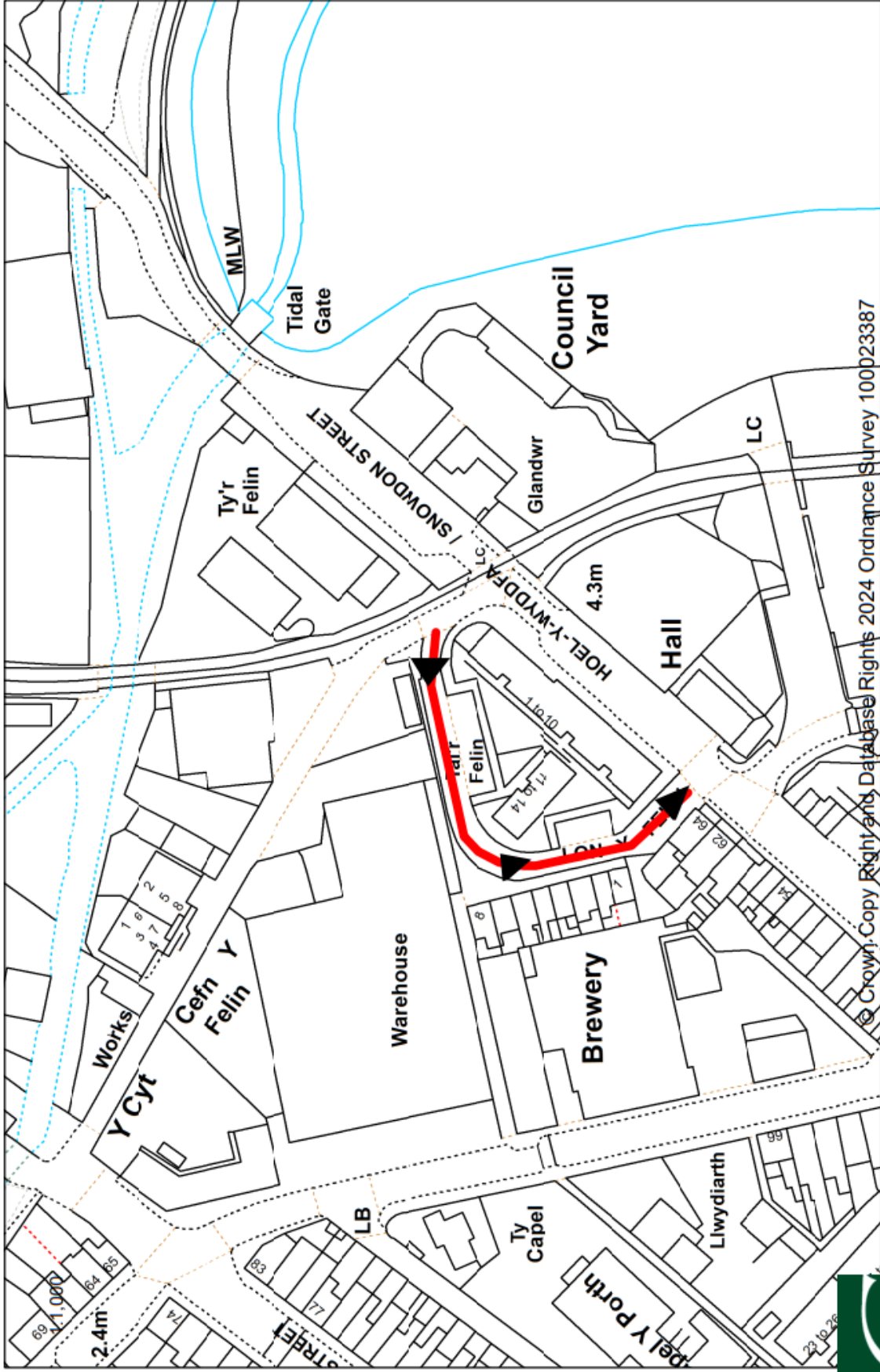

**(ONE WAY SYSTEM) ORDER 2024**

Cyngor Gwynedd (“the Council”) in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of the Police in accordance with Part 3 of Schedule 9 to the Act hereby make the following Order:-

1. No person shall cause any vehicle to proceed along the road specified in the first column of the Schedule hereto except in the direction specified in the second column of the Schedule.

This Order shall come into operation on the\*\*\*\* day of \*\*\*\*\* Two thousand and Twenty Four and may be cited as “Cyngor Gwynedd (Lôn y Felin, Porthmadog) (One Way System) Order 2024”.
